1 Important information re Urgent Suspected Referrals

The Pan London Urgent Suspected Cancer (USC) referral forms have recently been updated, taking into account comments from specialists, GPs and other stakeholders, and any changes in national referral guidance. In particular, changes have been made in the following forms:

- Gynaecological Cancer: incorporating new BMS guidelines for postmenopausal bleeding.
- Sarcoma: following launch of the new soft tissue sarcoma diagnostic pathway.
- Skin Cancer: adaptations made for teledermatology, to be used according to local pathway where these exist.

Other generic changes include:

- New Top Tips have been developed for Gynaecological, Haematology, Sarcoma and Urology, to add to the existing suite of Top Tips of Breast, Lower GI, Upper GI, with more to come in the next few months.
- Wording in the forms and patient information have been modified to reflect the latest Faster Diagnosis Standard.
- The NHS Service Finder website has been added for finding practice bypass numbers, available to those with NHS email addresses.
- In some forms, minor modifications to wording were made to make referral requirements or arrangements clearer.
- Boxes added under 'Other access needs' for referrers to provide more information about learning disabilities.

The new referral forms will be uploaded to the IT system that you use by your ICB commissioned IT service provider(s), your IT Leads or by DXS. If you encounter problems using the forms, please contact your borough's Cancer / IT lead or your IT service desk in the first instance.

It is important that only the new, updated USC referral forms are used after 25 October 2024. Please could you ensure that any old forms or templates are removed from your IT system and are no longer used for patient referrals.

We are also pleased to inform you that a brand-new video on how to send a good quality USC referral, developed in conjunction with GatewayC, has been published.

3 Targeted Lung Health Check Programme Update

We have completed over <u>10,000 CT scans and 25,000 telephone triages</u> as part of the Targeted Lung Health Check Programme (a free check for 55-74 year olds who have ever smoked).

Our uptake rate is one of the highest in the country and we are diagnosing around 62.2% of cancers at stage 1 or stage 2.

Expansion to Havering

We have now launched this in Havering, which follows Barking & Dagenham, Tower Hamlets and Newham (the order of boroughs is determined by smoking prevalence, along with IT integration).

All practices in Havering have been asked to sign a data sharing agreement via their Data Controller Console, and we have written to each practice with instructions. We ask that all practices action this as soon as possible please.

7 Cervical screening for people over 60

We have been made aware of an issue with the new Cervical Screening Management System. Many patients over 60 have been assigned as ceased to be invited, even though they may still be within the eligible age range

The Screening Quality Assurance Service (SQAS) have advised that, while the issue is being investigated and resolved, sample takers should continue to screen eligible people according to national guidance if they are due a test, and document on the form/flag with the lab that the person is eligible to ensure the sample is processed. CSL have been alerted to the issue and have made sure lab staff are aware, to reduce the risk of the sample being rejected as out of programme.

In the meantime, we would be grateful if any sample-takers who experience this issue complete and submit a screening incident assessment form (SIAF) with the details, which can be found here:

8 ONEL SMI Breast Screening (BHRUT)

THE ONEL SMI PROJECT IS NOW LIVE, having launched in Loxford and New Cross Alliance PCNs on 7 October. The next PCNs due to launch on 4 November are B+D East, North and New West PCNs, followed by Cranbrook and Fairlop on 25 November.

ALL OTHER PCNS: PLEASE DO NOT BEGIN INVITING PATIENTS UNTIL NOTIFIED TO DO SO. To ensure InHealth can facilitate screening invites, the next round of PCN launches will be in January 2025 and Nikki the project manager from the cancer alliance will contact PCNs when it is time to launch and to provide any crucial updates needed for practices to begin LIS activity.

9 Improving the quality of support that cancer patients receive

An exciting opportunity has arisen to improve the quality of support that cancer patients receive within the primary care setting through a process of reflection and quality improvement at practice level across north east London.

We are keen to support practices to improve how they:

- Explore and identify cancer patients' unmet needs
- Offer support to help meet these needs

We are asking practices to:

- 1. Run a CEG search to identify a maximum of 10 historical random cancer patients
- 2. Import the patients into a Reflection Tool and complete it for each patient
- 3. Reflect as a practice on the results and review the Resources & Recommendations we will be providing
- 4. Submit the anonymised search results and your practice improvement plan on what better support would encompass
- 5. After 2 quarters run the random search again (max 10 patients) and reflect on any changes to the quality of care or support offered
- 6. Send out a patient questionnaire to these patients (which we will have provided) to help the practice reflect on care provided
- 7. Submit a final evaluation form including the second search results, your review of your QI and the anonymised patient feedback results

An external evaluation will be conducted by SoWhat? Consulting Ltd

We will be supporting the practices with the above process and have the backing of the Place-Based Cancer GP leads and PCN Cancer Facilitators who are also keen to support in anyway needed.

We are offering £500 to each GP practice to be involved in this Quality improvement project, and we are aiming for 5 GP practices per area.
